### **General Admission Requirements**

- A bachelor's degree from an accredited four-year college or university which
- Graduate application for admission
- Official university transcript Requested and/or required official transcripts from other institutions must be sent directly to the admission office
- Letter of recommendation
- Entrance Essay
- Payment of non-refundable application and registration fees

# **International Students**

In addition to the general admission requirements, international student applicants should submit the following:

- Payment of applicable I-20 processing fee.
- Certified translation of non-English diploma.
- Bank or Financial Statements showing funds to cover tuition and living expenses for one year academic term.
  - Proof of financial ability in the form of Affidavit of Support
- Copy of valid passport, U.S. Visa and I-94
- Proof of English proficiency (for Applicants whose primary language is not English) through either of the following tests taken within the past 2 years:
  - o TOEFL score of 60 or higher for IBT, 170 or higher for CBT, 497 or higher for PBT. Use CTSB Code C229
  - o IELTS Academic score of 5.5 or higher Applicants can enroll in an approved ESL program to prepare for an English proficiency test. Test application requirements, test locations, schedule and fees can be obtained from either:
